The MEs decided to wait until tomorrow ( 0900 ) to perform the autopsy, as they would like to wait and see what was said in Sgt. SMYTH's statement.

Call daughter, Meghan DUNPHY, who said it was fine if I drop by.

13:45

Speak with Meghan DUNPHY, at her res. on Salmonier Line. Her boyfriend, Billy CORCORAN, was also present.

Meghan was open to talking about things, as she had several questions for police. She felt that the RCMP had not done anything that she had requested, so far. This was in reference to the name of her father being released. I told her that it was not the RCMP that released his name, and that we had no control over where this info had come from. She also took issue with SMYTH walking around the scene...she felt he should be in custody. I explained to her why this was not the case. She also felt that police were painting her father as the bad guy, talking about his drug use, the firearm, the state of the house, and all the cats.

I asked her if she had any questions for police, and she listed the following:

1. she wants to shut down her father's Twitter account, as it is still getting a lot of activity
2. at some point, in the future, she would like to speak with the RNC officer - I told her that this is highly unusual, but I said I would forward her request.
3. she would like to take possession of two, specific, cats from her dad's home. She said that they would come to her if she called them, from out on the street.
4. she wants to be the main point of contact for the family. She is an only child, and her mother is deceased.
5. she wants her father's cell phone. It is her phone, but he used it. The account is in her name, and she pays the bill.
6. she wanted to see her father's body, as soon as possible, after the autopsy. She was advised that this is usually done at the funeral home

I told her I would look into these things, and get back to her. I gave her my card, including my cell number.

She, also, advised that her father's silver Honda Civic was parked at her house, as her boyfriend was doing some repairs on it. Her boyfriend's Jeep was parked in the deceased's driveway, as he was using it, while his car was being fixed.

She also said that her father was mobile, and able bodied. He drove into St. John's, frequently, on his own. She also mentioned that his middle name was James.

Her father's cell phone was hers, but he used it. It was her old phone. It is on her account ( Telus ), which she pays.
