I called it at 6:00 p.m. and it was not answered and I called it again from my cell phone, my home number and my wife's cell phone over the next couple of days but did not get an answer either time I called.
- 4. That on Monday January 9th at approximately 11:15 a.m. I attended at the residence again and knocked on both doors upstairs with out luck. I noticed a tv on in the basement and knocked at the basement door and a lady answered and advised she was a home care worker and that Debbie and Richard were not home, that she had relieved the night shift worker at 9:00 a.m. and when she came in the Dunphy's were gone. I left and came back home.
- 5. That on Monday, January 9^{th.} at approximately 6:15 p.m. I attended at the residence again and the same home care worker answered the door and advised that neither Richard nor Debbie were home and hadn't been home all day. She didn't know where they were or when they would be coming home. I handed the envelope to her as instructed by the Commission and she refused to take it, I advised that it was from the Commission, was very important and it was imperative that she get it to Mrs. Dunphy. I asked her name for my affidavit and she refused. I touched her with the envelope and dropped it at her feet inside the home. I then left.
- 6. I believe that Mrs. Dunphy is avoiding service by not answering the phone and by leaving the home to avoid being served.
