Joe Smyth has just informed me via BBM that he was involved in a shooting and the suspect is deceased.

He was in Mt. Carmel (he had advised Holyrood Det) checking on a Mr. Don Dunphy who had posted a twitter message of concern on Friday, making reference to 'two dead MHAs'.

Dunphy pulled a firearm on Smyth.
